As a Firearms Examiner for CSPD's (Colorado Springs Police Department) Metro Crime Lab, you will perform firearm and toolmark examinations, prepare technical reports that support analytical findings, and present them in a court of law through expert witness testimony.

This is a grant-funded position with funding through October, 2021 and the possibility of an extension.

Essential Job Functions - the basic job duties an employee must be able to perform:

- Perform mechanical function examinations of a wide-variety of firearms
- Identify and analyze firearms and related physical evidence, such as ammunition, ammunition components (bullets, cartridge cases, shot shells, etc.), and gunshot residue patterns, etc.
- Provide evaluation and acquisition of appropriate evidence for entry into IBIS/NIBIN (Integrated Ballistics Identification System/National Integrated Ballistic Information Network)
- Perform microscopic comparisons of ammunition and ammunition components
- Prepare non-firearm related toolmark comparisons
- Collect and preserve evidence; examine evidence using various laboratory techniques; and interpret analytical results
- Perform muzzle to target distance determination

- Provide training for law enforcement academies, officers, and attorneys in the firearms and toolmark disciplines
- Perform serial number restoration
- Assist with maintaining the lab's Firearms and Ammunition reference collection, including auditing procedures
- Ensure maintenance of all equipment

We are looking for candidates who demonstrate:

- Knowledge of operations, services, and activities of a crime lab
- Knowledge of legal procedures for the admission of evidence in criminal investigations
- Knowledge of equipment, materials, and supplies used in a crime lab
- Knowledge of pertinent federal, state, and local laws, codes, and regulations
- Ability to work under stressful conditions
- Ability to stay abreast of current technologies and procedures
- Ability to testify in court proceedings as an expert witness
- Ability to communicate clearly and concisely, orally and in writing
- Ability to establish and maintain effective working relationships

This position requires the ability to work independently and exceptional organizational skills.

- Bachelor's degree from an accredited college or university with major coursework in general chemistry, analytical chemistry, physical chemistry, biology, microbiology, criminology, or other forensic related science field
- Three years of full-time forensic laboratory experience in firearm and toolmark examinations, including experience as an expert witness
- Possess and maintain a valid, non-probationary Colorado driver's license not subject to restriction related to alcohol and/or drug violations or pending charges
