- Trainee - Forensic Scientist 1, salary \$21.60
- Forensic Scientist 1, salary range \$25.71-\$37.82/hourly: \$53,682-\$78,968/annually
- Forensic Scientist 2, salary range \$29.50 - \$43.77/hourly: \$61,596-\$91,392/annually
